SERVICES ON DEMAND

- Rental deposit: **€250** for setting up + **€10/month** of management fees
- Cash deposit into your own account at a POST point of sale: **free**
- Account statement and visa statement: **€2/per document**
- Cash withdrawal at a POST point of sale: **€8**
- Paper transfer: **€8**
- Custom request with prior approval from the client (duplicates, searches, confirmation of balances, etc.): **on quote**
- Duplicate & balance confirmation: **€8**

INTEREST PAYABLE

Account balance < €0

- Unauthorised overdraft: 12% per year
- Authorised overdraft: 8% per year

DEFERRED REPAYMENT

- Late debit at the end of month with Visa credit card
- Payment with the possibility of repaying over **10 months with the Visa Gold card**
- Interest rate on the remaining balance due **at 12% per year with the Visa Gold card**

KNOW YOUR CUSTOMER Non-regularisation of customer file – blocking fees: **€100**

DORMANCY Fee for accounts that have been inactive for 10 years – **€250**. Charged up to the limit of the available balance in the account prior to closure, before the balance is transferred to the escrow account.
