#### Term, renewal and termination

The minimum contract term is 24 months. The customer may subscribe to options with a different contract term, it being understood that this term may not exceed the minimum contract term of the offer. Beyond this, the Contract is automatically kept in its initial state indefinitely. During this period, the Contract may be terminated at any time by giving one month's notice. It is also possible to terminate the Contract early, again giving one month's notice, but in this case you will be charged cancellation fees equivalent to all monthly payments due until the contract expires. You will also be asked to pay the outstanding value of the hardware as its price is subsidised through the monthly subscription. All contract termination notifications must be sent by registered letter, express message or, if available to the customer in question, via the customer's online personal space provided by POST Telecom. The customer also has the option to complete and sign a termination form in a physical POST Telecom point of sale.
