**Term, renewal and termination**

It is also possible to terminate the Contract early, again giving one month's notice, but in this case you will be charged cancellation fees equivalent to all monthly payments due until the contract expires. You will also be asked to pay the outstanding value of the hardware as its price is subsidised through the monthly subscription. All contract termination notifications must be sent by registered letter, express message or, if available to the customer in question, via the customer's online personal space provided by POST Telecom. The customer also has the option to complete and sign a termination form in a physical POST Telecom point of sale.
